

RELEASE AND WAIVER OF LIABILITY

To: Attending Patron(s) (hereinafter referred to as “**Patron**”)

(hereinafter referred to as “**SDID/Mile High Social Dances**”)

Whereas Patron participating in dance lessons, social dances, or any event or activity with SDID/Mile High Social Dances and is doing so entirely upon Patron’s own initiative and responsibility, and recognize that dancing requires physical exertion that may be strenuous and may cause physical injury, and Patron is fully aware of the risks, injuries, dangers and hazards involved.

COVID-19 (and/or other variants)

In consideration of Patron’s participation, the undersigned acknowledges and agrees to the following:

Patron is aware of the existence of the risk on Patron’s physical attendance and the attendance of Patron’s guests to the venue and Patron’s participation in the activities at SDID/Mile High Social Dances. Attendance may cause injury or illness such as, but not limited to Influenza, MRSA, or COVID-19, or any variant thereof (hereafter referred to as “COVID-19”) that may lead to paralysis or death.

Patron has not, nor any members of Patron’s household or event guests experienced symptoms of fever, fatigue, difficulty in breathing, dry cough, or lack of taste or smell within the last 10 days.

Patron has not, nor any members of Patron’s household or event guests been diagnosed with COVID-19 within the last 10 days.

Patron has not, nor any members of Patron’s household or event guests been exposed to COVID-19 in the past 14 days.

Following the pronouncements above Patron hereby declares the following:

Patron is fully and personally responsible for Patron’s own safety and actions. Patron recognizes that even while following the public health guidance Patron may still be at risk of contracting COVID-19.

With full knowledge of the risks involved, Patron hereby unconditionally agrees to release, waive, discharge, indemnify, defend, and hold harmless SDID/Mile High Social Dances, their owners, agents, and representatives and fellow Patrons, from and against any and all costs, expenses, damages, personal injuries, losses and/or loss or theft of Patron’s belongings or property, property damage, lawsuits, and/or liabilities, claims, demands, actions and causes of action, or death, or related to COVID-19, or any other sicknesses, injuries or damages, known or unknown, whether directly or indirectly from or related to any and all claims made by or against SDID/Mile High Social Dances which Patron might incur as a result of attending and/or participating in any event or activities at SDID.

By signing below Patron acknowledges that Patron has read the foregoing Release and Waiver and understands its contents; that Patron is at least eighteen (18) years old and fully competent to give Patron’s consent; that Patron has been sufficiently informed of the risks involved in attending SDID/Mile High Social Dances events.
